





MEMORANDUM

RE: Feasibility to Cause Installation of Sewer Line along  
Cortez Street into Baltimore Street Sewer  
(To Service One House)

An investigation of data regarding the installation by the City of a sewer line in Cortez Street (connecting into the Baltimore Street sewer) revealed a great deal of ledge in the area of Cortez Street at its intersection with Baltimore Street. (See attached profile of Cortez Street - Exhibit 1). Because of extensive ledge condition, the installation of said sewer line and manholes would be extremely costly to the City of Providence which we estimate to be in excess of Forty Thousand (\$40,000) Dollars.

It is also noted that installation of private lines such as this are the responsibility of the property owner, and NOT the responsibility of the City. In fact, recently, in two similar cases private contractors installed sewer lines not the City.

The only requirement that this department asks is that the sewer be installed to City of Providence standards, proper permits be taken out at our engineering office, and that the installation of said line be done by a bonafide drainlayer or construction company experienced in this matter.

In view of the aforementioned facts, I feel that the Department of Public Works should deny the installation of said sewer line in Cortez Street as requested by Councilman Cola in the City Council docket of 11/5/87. (See Exhibit 2 attached hereto).




EXHIBIT #1
