RESOLVED,

THAT upon payment of the outstanding balances of the taxes assessed against the Boston & Providence R.R. Corp., and Providence & Worcester R.R. Co., for the year 1960, in the sum of FIFTY-SEVEN THOUSAND EIGHT HUNDRED EIGHTEEN and 98/100 (\$57,818.98) DOLLARS; for the year 1962, in the sum of FIFTY-ONE THOUSAND TWO HUNDRED FORTY-SIX and 37/100 (\$51,246.37) DOLLARS, and for the year 1963, in the sum of FIFTY-ONE THOUSAND TWO HUNDRED NINETY-SEVEN and 07/100 (\$51,297.07) DOLLARS, making a total of ONE HUNDRED SIXTY THOUSAND THREE HUNDRED SIXTY-TWO and 42/100 (\$160,362.42) DOLLARS, the City Collector is thereupon authorized and directed to abandon under Section 6 of Chapter 46 of the Public Laws of 1961 the amounts of taxes listed below, which amounts shall be deemed abated and cancelled; Provided further, however, that at least 90% of the requested abatements in the total amount of ONE HUNDRED FIFTY THOUSAND SIX HUNDRED FORTY and 66/100 (\$150,640.66) DOLLARS are abated by Providence, Central Falls, Cumberland, Lincoln, Pawtucket, Woonsocket and North Smithfield.
