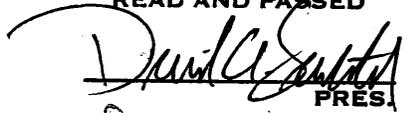

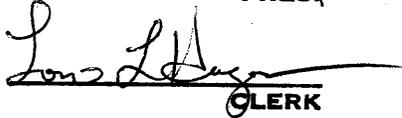

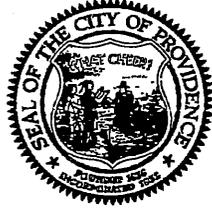

Dear Mayor Elorza:

Acting Director Bucu respectfully requests approval to piggyback RI MPA 41 with C&K Electric Company Inc., for the conversion of 2,088 Decorative Light luminaires to LED technology, including the replacement of 1,264 Acorn style globes.

Although an initial and considerable investment, this LED Decorative Street Light conversion will save the City on future costs of replacing luminaires, greatly reducing annual maintenance expenditures, and will result in reduced electricity use.

Acting Director Bucu respectfully requests approval to enter into an agreement with C&K Electric, Inc., for the conversion and upgrades, in a total amount not to exceed Eight Hundred Eleven Thousand One Hundred Fifty Six (\$811,156.00) Dollars.

- Furnish and install 15- GTR-PT-M21-40-SV-BL-NL 35W post top LED upgrade kits Including disposal of old lamps, drivers, ballasts.
- Furnish and install 202- LES-50-740-HWD-EY04-UNV-3N 50W LEDioc post top LED upgrade kits including disposal of old lamps, drivers, ballasts.
- For each pole, provide pre-numbered weatherproof labels to be affixed at 6' AFG

- Perform field audit of decorative street light poles within this scope in order to capture the following data as it pertains to each individual pole (final report to be delivered in Excel format):
  - Pole Number
  - Nearest Street Address
  - GPS Coordinates
  - Type of LED upgrade installed
  - Photo of pole displaying pole number tag
  - General assessment of paint condition (Good, Fair or Poor)

- Listing of broken or missing parts including specific photo documentation if applicable

Exclusions: Police detail(s), overtime hours, lighting branch circuit troubleshooting or repair

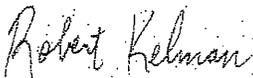

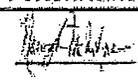

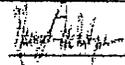
