RESOLUTION OF THE CITY COUNCIL

No. 264

Approved June 14, 2004

IT IS HEREBY RESOLVED, That His Honor, the Mayor, is authorized to grant an utility easement for the removal and reinstallation of a fiber optic and electrical duct bank on Dudley Street in the City of Providence to Rhode Island Hospital located at 593 Eddy Street, Providence RI. Said easement shall be granted specifically upon the following provisions:

1. Said easement shall be utilized in conjunction with the new emergency department at Rhode Island Hospital (A.P. 22 8 46). Two of the conduits house fiber optic lines (one being a spare) which provides service to an existing building—security cameras, help buttons, card swipes and data signals of all the parking controls for our existing lots: C1, E3, E6, E7. The other two conduits supply electrical power (one is a spare) to the parking to the property located on Dudley Street between Plain Street and Culver Street between lots 349 and 53. Said easement shall not exceed the area of one-hundred fifty square feet, plus or minus, with dimensions of fifty feet by three feet and indicated on the accompanying map marked as Exhibit A.

2. Said easement shall be deemed to run with the land and shall operate against any successors in title and the easement or a memorandum of same shall be recorded by Rhode Island Hospital in the Office of Land Records for the City of Providence.

3. Said easement shall be subject to a right of reverter/right of reversion in the event that the situs of the easement is no longer utilized for the aforesated purposes.

4. Rhode Island Hospital shall execute an indemnification and hold-harmless agreement with the City of Providence. Said agreement shall be approved by the Department of Law of the City of Providence.

5. Rhode Island Hospital shall supply the City of Providence with an insurance policy naming said City of Providence, its agents, officers, servants and employees as additional-named insureds in a sum not less than one hundred thousand dollars (\$100,000.00) which policy shall be approved by the Department of Law of the City of Providence.

6. In the event that the City of Providence or its designee shall, for any public purpose, require the extinguishment of the easement granted herein, upon the ninety (90) days notice, Rhode Island Hospital shall, at its own expense, and without claim against
