Solomon, pursuant to Section 406 of the Providence Home Rule Charter of 1980 and Rule 3 of the Rules of the City Council, requested the City Clerk, in writing, to Call a Special Meeting of the City Council to be held on Monday, April 30, 2012 at 5:00 o'clock Regular City Council Meeting, in the City Council Chamber, Third Floor, City Hall for the purpose of Enacting the following:

RESOLUTION AUTHORIZING THE CITY OF PROVIDENCE TO TAKE ALL NECESSARY ACTIONS TO CHALLENGE CONSENT DECREE ON COST-OF-LIVING (COLA) ALLOWANCES.
