Approved June 7, 1963

WHEREAS, people in countries throughout the world have been deeply moved and saddened by the death on June 3, 1963 of His Holiness Pope John XXIII, and

WHEREAS, his dynamic pontificate, dating from November 4, 1958 - though relatively brief - encompassed every phase of papal activity. He was seventy-seven years of age and had been a priest of God for fifty-four years when he ascended the throne of Saint Peter and astounded the world with his accomplishments. "The Servant of the Servants of God" knew his time was short. To bring to fruition his ideals for peace, brotherhood and the temporal betterment of the peoples of the world, necessity required that he speak often and forcibly as evidenced by his numerous and now famous encyclicals, and

WHEREAS, this former humble peasant boy whose teaching voice reached not only 558 million Roman Catholics but all men causing him to be cited as a universal father. To implement his belief in the "Brotherhood of Man under the Fatherhood of God", he called the Second Ecumenical Council, the first of its kind in almost one hundred years. He opened the council, in solemn grandeur, on October 11, 1962 with 2500 prelates present. Forty non-catholic observers, given front row seats, marvelled at the framework "The Pope of Unity" had built and which yielded the most good will at such a high level since the Reformation, and

WHEREAS, His Holiness Pope John XXIII, patriarch of more than half a billion souls, no longer reigning as the Vicar of Christ on earth, is deeply mourned by them and by millions of others who are not of his fold.

NOW, THEREFORE, BE IT RESOLVED, that this resolution be recorded on the permanent records of this city council and a duly certified copy of the same be forwarded to the Most Reverend Russell J. McVinney, D.D., Bishop of the Roman Catholic Diocese of Providence.
