Resolved,

That the following Minute on the life and character of the late Most Reverend Thomas F. Maloney, D.D. Auxiliary Bishop of Providence, whose death occurred on September 10, 1962 is hereby adopted, ordered inscribed on the records of this city council and a copy transmitted to the family of the deceased.

M I N U T E

Most Reverend Thomas F. Maloney was a native of the City of Providence and the son of the late Thomas F. and Hannah T. (Daley) Maloney. His birth date was April 17, 1903. He received his early education at Cleary School and was graduated from LaSalle Academy with the class of 1922. After two years at Providence College, he studied for the priesthood at Louvain, Belgium and was ordained at the American College on July 13, 1930. He celebrated his first solemn high Mass in St. Joseph's Church on Hope Street, his native parish.

His first priestly duties were as Chaplain at St. Joseph's Hospital, Elmhurst Academy and St. Mary's Academy - Bayview. In 1934 he was assigned to St. Paul's Church in Cranston and remained there for 18 years until he was selected by a board of American Bishops to re-open the American College at Louvain which had been closed during World War II. Leaving here in the spring of 1952, he returned to his war-ravaged Alma Mater, enrolled the first post war class in September of that year and four years later, twenty-four young men were ordained to the holy priesthood. The late Pope Pius XII on February 17, 1955 named him a Domestic Prelate with the title of Right Reverend Monsignor for his accomplishments as Rector of the American College and the Belgium Hierarchy conferred on him further honors, as Professor Extraordinary of Theology.

Pope John XXIII, on January 6, 1960, named him auxiliary to the Bishop of Providence with the titular see of Andropolis in the Province of Alexandria in Egypt, the first auxiliary bishop in this diocese in more than forty years. His consecration took place on May 11, 1960 at the Cathedral of Sts. Peter and Paul. In addition to his other ecclesiastical duties, he was Pastor of St. Sebastian's Church from August, 1961 until he passed away.

Bishop Maloney was a humble priest who gave to every assignment, his meticulous care and attention. His monumental accomplishments merited the signal honors bestowed on him. Simplicity, humility and kindness were a part of his every endeavor earning for him the respect and admiration of everyone with whom he came in contact. His life exemplified the motto chosen for his coat-of-arms - "One who Serves".




