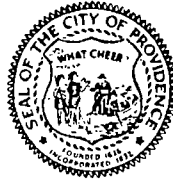


Dear Councilor Igliazzi:

1997 to Present Assistant Superintendent for Management

As a member of the Superintendent's Senior Staff, duties include overseeing offices of: Student Relations, Alternative Education, Placement and Registration, and Summer School, as well as Parents Making a Difference. Additional duties include the responsibility for school safety issues, involvement and resolution of day-to-day K-12 management issues, working with individual, family, community and partnership issues. Preparing reports, statistics, working with Zone, Health, and Human Resources Administrators in dealing with issues ranging from Health to Home Schooling to OJI and Workers' Compensation, to working with schools and colleges to facilitate placement of practicum and student teachers and providing workshops/staff development for new and acting administrators fall under the responsibility of this position. Attendance at grievance hearings, Senior Staff Meetings is required. As Assistant Superintendent for Management I must be ready to assume any and all other duties which may be assigned by the Superintendent: Safety Committees, Salt Data Collection, Administrative Workdays, Magnet, OCR, and Desegregation meetings, etc.
