WHEREAS, The intent is the same objective as to trespass from Point "A" to Point "B" illegally, to get or do something at Point "B",

NOW, THEREFORE, BE IT RESOLVED, That the 1982 Session of the General Assembly hear the plea from the public and prevent the culprits who get caught in the act and get off with a simple charge of a misdemeanor because they did not get a chance to complete their job which still leaves the victim with expensive property damage.


