Dear Ms. Brassil and Mr. Xavier:

The 1983 Brown University Spring Weekend activities are slated for Thursday, Friday, Saturday and Sunday, April 28, 29, 30, and May 1. I am requesting your approval for the following street closings which will assist in making the planned activities much safer due to the number of people in the area.

On Friday 29 April I am requesting that Thayer Street be closed from Waterman Street south to George Street during the time period of 6:30am to 7:00pm. This would accomodate the anticiapted heavy pedestrian traffic in the Hegeman/Caswell Courtyard area.

On Saturday 30 April I am requesting that Meeting Street and Cushing Street, from Brook Street to Hope Street be closed to traffic from 6:30am to 5:00pm. This would accomodate the pedestrian traffic for an outdoor concert at the Pembroke Field House.

On Sunday 1 May I am requesting that Charlesfield Street, from Brook Street to Hope Street be closed to traffic from 12:00 noon to 6:00pm to accomodate the East Campus Block Party.
