AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1983-30 APPROVED JULY 10, 1983 BY TRANSFERRING THE SUM OF SIXTY-THOUSAND DOLLARS (\$60,000.00) FROM THE LAW DEPARTMENT CLAIMS ACCOUNT (1-001-05-331) TO THE WORKERS COMPENSATION ACCOUNT (1-013-17), AS AMENDED.

Approved July 16, 1984

Be it ordained by the City of Providence:

SECTION 1. Chapter 1983-30 of the Ordinances of the City of Providence, as approved July 10, 1983, entitled: "An Ordinance making appropriation of One Hundred Sixty-Nine Million, Seven Hundred Ninety Six Thousand, Two Hundred Forty Dollars and Ninety-Six Cents (169,796,240.96) For the Fiscal Year ending June 30, 1983, as amended", is hereby further amended by transferring the sum of Sixty Thousand Dollars (\$60,000.00) from the Law Department Claims Account (1-001-05-331) to the Workers Compensation account (1-013-17). The transfer would be effected as follows:

(1-013-17-3-92)	32,000.00
(1-013-17-1-02)	20,000.00
(1-013-17-1-99)	\$ 2,000.00
