Dear David:

I am writing you in regards to the request for streetlights in several locations off Hope, Morris, Montague, and Doyle St in Providence. Narragansett Electric has visited each site and evaluated the feasibility of installing lighting. At this time there are several issues that prohibit Narragansett Electric from installing any lighting.

- There are no poles in any of the present locations. To install poles in these locations Narragansett Electric would require easements from all of the property owners and agreed locations for the poles.
- The overhead wires to feed the poles would also need aerial easements for the property's that they cross getting to the poles.
- The wires and poles would need to be located in places where they would meet both the NEC and Narragansett Electric standards for clearance from buildings and road ways.

Lastly there would be charges associated with the engineering and installation of these poles and lights. If you are interested in perusing this further Narragansett Electric would require a written request for the lights. Upon receipt of the letter Narragansett Electric would do the preliminary engineering and develop an estimate for the city's review before issuing a bill, and ultimately starting construction.
