ELECTION OF CLERK OF THE PROBATE COURT

The City Council proceeds to elect the Clerk of the Probate Court in accordance with the provisions of Section XI of Chapter 3340 of the Public Laws of 1954, approved April 26, 1954, entitled: "An Act in Amendment of Clause I of Section XI of Chapter 598 of the Public Laws, 1866 as Amended, Relating to the Probate Court of the City of Providence."

FRANK S. LOMBARDI, ESQUIRE, only nominee, was nominated for the remainder of the term ending on the first Thursday, in November, 1995, at the regular meeting of the City Council held on THURSDAY, NOVEMBER 17, 1994, which date has allowed for the elapsed time of twenty days, between the nomination and the election of Clerk of the Probate Court.

The nomination of FRANK S. LOMBARDI, ESQUIRE, as Clerk of the Probate Court is thereupon taken from the City Clerk's Desk on motion of COUNCILWOMAN IGLIOZZI, seconded by COUNCILMAN DILLON.

The City Council thereupon proceeds to elect FRANK S. LOMBARDI, ESQUIRE, only nominee as Clerk of the Probate Court of the City of Providence, on motion of COUNCILMAN IGLIOZZI, seconded by COUNCILMAN ROLLINS and COUNCILMAN CLARKIN.

COUNCILMAN LOMBARDI desires to be recorded as "Not Voting".

COUNCIL PRESIDENT PETROSINELLI thereupon declares FRANK S. LOMBARDI, ESQUIRE duly elected Clerk of the Probate Court of the City of Providence for the remainder of the unexpired term of ELAINE BUCCI, ESQUIRE ending on the First Thursday of November, 1995.
