AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1985-69 APPROVED JUNE 25, 1985, BY TRANSFERRING THE SUM OF THIRTY-EIGHT THOUSAND (\$38,000.00) DOLLARS, FROM INTEREST ON TAX ANTI-CIPATION NOTES (1-002-24-3-13) TO PROVIDENCE HOUSING AUTHORITY.

Be it ordained by the City of Providence:

SECTION 1. Chapter 1985-69 of the Ordinances of the City of Providence, as approved June 25, 1985, entitled: "An Ordinance Making an Appropriation of One Hundred Eighty Million Six Hundred Sixty-Nine Thousand Three Hundred Ninety-Nine Dollars and Eighty-Eight Cents (\$180,669,399.88) for the Fiscal Year Ending June 30, 1986, as Amended is hereby further amended by transferring the sum of Thirty-Eight Thousand (\$38,000.00) Dollars from Interest on Tax Anticipation Notes (1-002-24-3-13) to Providence Housing Authority.

SECTION 2. This Ordinance shall take effect upon its passage.


