PERSONAL EXPRESSION

COUNCILMAN DeLUCA requests the privilege of the floor to speak on a point of personal expression and states:

"I rise this evening on a point of personal expression and I have three issues that I would like to address.

The first issue is the recent decision of the City Solicitor regarding the Providence Review Commission.

Whenever a Law is passed there is always the intent of the legislative body, which is extremely important, to write notes explaining why they voted and the intent is extremely important. This legislative body voted June 15th and amended the Ordinance regarding the Providence Review Commission and left out some things that should have been in there, such as when the commission starts, continuity and so forth and so on and we did that but there was no intent whatsoever by this legislative body to break up or to disband or cease to exist, the Providence Review Commission. In fact, we all assumed that commission was going to continue operating as it had been. If I'm wrong, that this body had other intentions please tell me. No one ever intended to discontinue the services of the Providence Review Commission and therefore, I would have to state that the City Solicitor is in error in sending a letter informing the commission members that they are no longer in business. In fact, this legislative body had no intentions of ever rescinding the continuity issues of the Providence Review Commission and we expect them to stay and to continue doing the fine work that they have been doing, especially during these troublesome times. I disagree with the City Solicitor's opinion and this legislative body carries more weight than the City Solicitor. Therefore, I say that the commission is valid until we replace it and until we do so, it should be valid and working and that is my opinion on that issue.

Another issue that has been bothering me for a long time now, as most of you know, is the Legal Fund regarding the 1033 Laborers' Union and next week I will be introducing a resolution asking the Attorney General to investigate the use of public funds for their Legal Fund and a relationship between a certain member of a non profit organization. We have no idea what this is being used for if anyone uses the fund, or what, and who used it and the only ones that can use it are the union people and are these uses being recorded?

For the past several years, this body we pay for 1033, healthcare, the City paid for vacation, sick days, holidays, etc. and we gave them a pretty good incentive benefit package and . . . they are ridiculous. Thank you."

COUNCILWOMAN NOLAN requests the privilege of the floor to speak on a point of personal expression and states:

"I feel like I have to address the Providence Review Commission. Three Council Members, City Solicitor, two current members of the Providence Review Commission met once a week for several weeks to bring the . . . issue of why . . . for the City Charter. I want to say that I was very disappointed to see that a letter went out disbanding the Commission without any notice to the City Council people and I think as a whole it should have said it was not our intention ever to disband the Commission but for them to continue their work and I have received phone calls on a daily basis and I receive quite a few letters a day from people who . . . who were there who were . . . this is the second time after . . . that there is something that has occurred concerning the Providence Review Commission

... to make it possible for City workers to become members of the Commission ... unless that has changed that ... I understand that the Finance Committee is very busy but I also know that ... and I urge the Chair of the Finance Committee to put this matter on the agenda immediately so that we can follow this up and resolve this issue, and change the bad Press.

Other than that, over the Fourth of July Weekend, I was amazed to hear from many of my constituents that when they called the police station to report loud parties, the use of illegal fireworks, etc., they were told that the police would not be responding to these types of calls until after 9:00 o'clock P.M. I was appalled.

I don't have the Noise Ordinance in front of me, nor do I have the Ordinance or State Law on illegal fireworks, but I don't believe a time of 9:00 o'clock P.M. is mentioned.

Last year, I put in a resolution to purchase noise meters out of the Seizure Funds and that they be made available to the Patrol Division and the Community Police Officers. The police department did purchase those meters, but I have yet to see them being used.

I have written to the Chief and asked for a list of summonses issued for noise since the meters were purchased and I'll bet they'll be few and far between.

Last night, I had a call from several constituents about a loud party and I could clearly hear the noise over the telephone. Often, these loud parties lead to other crimes; drugs, alcohol abuse and in one case, in my neighborhood, a shooting.

People don't leave Providence because of robberies, etc. people leave the City of Providence because they do not have the quality of life they want in the neighborhoods. You have to be able to at least, be able to sit in your yard and enjoy it, or sit in your house and watch television, whatever you want to do without having a party next door, blasting music into all hours of the

night. I think it is time that the Providence Police Department support the Noise Ordinance. It just wasn't written for the heck of it, it was written because there is a real problem in the neighborhoods and we want enforcement of the Noise Ordinance, and we don't want to wait until 9:00 o'clock P.M. Thank you very much."

COUNCILWOMAN YOUNG requests to speak on a point of personal expression and states:

"I must continue the trend. I have the same problem in my area as Councilwoman Nolan and it has been going on for years. ... there is absolute, non-stop drug dealing on the street. You call the police and they never respond. There are many young people out there selling drugs, almost everyday and no one ever shows up and you are talking about the quality of life? That wouldn't even be tolerated in other Cities and Towns. But, in my neighborhood, on many, many, occasions, this type of behavior is, it seems encouraged.

There is a very serious problem in the neighborhoods, not only loud parties but in my neighborhood your talk about drugs, drive by shootings etc. and the police just come by and disperse the kids and as soon as they leave three minutes later they are back doing the same thing ..."

COUNCILWOMAN DiRUZZO requests to speak on a point of personal expression and states:

"To repeat the comments that were made by two of my favorite Council people, let me just say that this City is out of control, there is no question about it and I think we all know it. There are people that are beginning to wonder whether we as Council people, are their elected choices, care

about their needs anymore. I had a neighborhood meeting about a week and a half ago and I had the team there and department directors and the Chief and the Commissioner, the community police were there who are assigned to the Silver Lake area and they were all there and it is a resounding voice out there. Everyone is saying the same thing, where all the . . . when they call the police department . . . cannot respond. With all we said and now there are no police officers there at the telephones anymore evidently it is getting worse. Either they are not being told to take the right information or they are not answering the phones. I don't know what the problem is, but I know it is very frustrating to call the police department and in my neighborhood all I hear is what's wrong with the police department? People are being disturbed at 11 and 12 o'clock at night and they have to work just like everyone else and get up early in the morning.

When I called up one night, I asked to speak to the officer in charge and my response was "officer in charge of what?" Of, what? The police department! I guess now they have an officer in charge of this division, an officer in charge of that division, the rules have changed. So, now you have to be specific in who you want to speak

to. Well, it is very frustrating to me and to my constituents.

Actually, you get to the point of where you begin to wonder, if I can't help my people and I can't help myself, who am I going to go to for help and how am I going to get it? It is an overwhelming problem in the City and we have to do something about it and I'm not sure how to do that. Do I have a problem speaking English? Is there a problem with my speech? I'm tired of saying the same thing and getting no response and something is unquestionably wrong and there is a breakdown here in the City and I'm not quite sure what it is.

All we are trying to do in our work is to improve the quality of life in the neighborhoods. Why do people leave Providence? For lots of reasons. One is that they can't live the way they want to live. They can't sit in their backyards, they can't sit out on their porches, they can't anymore, because other people are taking over the neighborhoods and it is an unfortunate situation because, they really don't want to leave the City but they are being forced to leave the City. It is embarrassing."
