No. 17 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE
CHAPTER 1984-53 APPROVED JULY 20, 1984, BY TRANSFERRING VARIOUS
SUMS OF MONEY WITHIN VARIOUS DEPARTMENTS.

Be it ordained by the City of Providence:

SECTION 1. Chapter 1984-53 of the Ordinances of the City of Providence, as approved July 20, 1984, entitled: "An Ordinance making an Appropriation of One Hundred Seventy-One Million, Fifty Six Thousand, One Hundred Seventy-Seven Dollars and Fifty Seven Cents. (\$171,056,177.57) for the fiscal year ending June 30, 1985, as amended", is hereby further amended by transferring various sums of money within various departments.
