Establishing the Classes of Position, the Maximum Number of Employees and the Number of Employees in Certain Classes in the Water Supply Board and Repealing Ordinance Chapter 1994-43, Approved November 23, 1994.

Approved April 29, 1996


Be it ordained by the City of Providence:

Section 1. The maximum number of employees in the Providence Water Supply Board shall not exceed two hundred fifty four (254) at any one time. Within each of the following classifications, there shall be no more than:
