SUBJECT: Resolution No. 601 - Barnes Street at Brown Street

Gentlemen:

The Traffic Engineering Department has studied the advisability of installing boulevard stop signs on Barnes Street at its intersection with Brown Street, as requested by City Council Resolution No. 601 dated December 2, 1955.

The various factors comprising the traffic conditions in this area, including volumes, speed, visibility and accident record, has been appraised; and as a result of these investigations, it is the opinion of this department that no stop regulation is necessary at this intersection at this time.

As you know, this department maintains a complete record of all reported accidents. In the event of any sudden change in the accident record at this intersection, it will be reviewed again at a later date.

SUBJECT: Updike Street and Whitmarsh Street

Gentlemen:

On December 2, 1955 a petition was received by the Committee on Public Works and was referred to the Traffic Engineer to report and recommendation.

As a result of the studies which followed, a STOP regulation has been ordered for the intersection of Updike and Whitmarsh Streets as indicated on the attached regulation No. TR-WO-1680.

A NO PARKING regulation has also been ordered for the west side of Updike Street, from Whitmarsh Street to Public Street, as indicated by the attached regulation No. TR-WO-1703.

The third request contained in the same petition was for two-hour parking on Whitmarsh Street from Broad Street to Elmwood Avenue. Investigations made of parking conditions on Whitmarsh Street indicates that there is a considerable number of parking spaces available at most times of the day, and that the number of all-day parkers are very few in number. As a result of this investigation, it is the recommendation of this department that no time limit be established on Whitmarsh Street at this time.




SUBJECT: STOP CONTROL - UPDIKE AND WHITMARSH






