

Dear Mayor Smiley,

The Department of Public Works respectfully requests to amend the cap of Sidewalk Road & Drainage Construction (Blanket Contract 2022) for Option Year 1 in the amount of \$250,000.00. The new overall cap for the contract will be \$10,839,840.80.

This amendment is necessary to:

- Add the DPW Revolving Account (621-621-53500) to the contract so that DPW can engage the services of one of the approved contractors to complete gaps in utility restoration paving areas and/or repair minor road deficiencies that the utility companies are not responsible for paving/repairing. The contractor selected in each instance will typically be the contractor that the utility company has hired to perform the road restoration and will perform the DPW requested work concurrently with the utility company restoration work.




