No. 367 **AN ORDINANCE** AMENDING THE APPROPRIATION, ORDINANCE CHAPTER 1981-39, EFFECTIVE JULY 20, 1981, BY TRANSFERRING THE SUM OF TWO HUNDRED THIRTY-FIVE THOUSAND DOLLARS (\$235,000.00) FROM VARIOUS DEPARTMENTS TO WASTE COLLECTION, ITEM I.

**Be it ordained by the City of Providence:**

SECTION 1. Chapter 1981-39 of the Ordinances of the City of Providence, effective July 20, 1981, entitled: "An Ordinance Making Appropriation of \$149,862,122.09 for the Support of the City Government for the Fiscal Period Beginning July 1, 1981 and Ending June 30, 1982", as amended, is hereby further amended by transferring the sum of Two Hundred Thirty Five Thousand Dollars (\$235,000.00) to 1-05-07 Waste Collection as follows:
