
RE: YMCA Address Changes

In August I wrote you on behalf of the YMCA to request a City Council resolution to add additional addresses for Postal Service purposes. I understand that since that letter you have submitted the resolution and that the Committee has reviewed it and received Post Office input. (A copy of the initial request is enclosed for your information). As the Postal Service stated when they replied to you, they will allow us to use all numbers up to 182. Therefore, the YMCA now requests the resolution be amended to include numbers 174, 176, 178, 180 and 182 in addition to the addresses previously requested. 
