COMMITTEE ON URBAN REDEVELOPMENT, RENEWAL AND PLANNING

COUNCIL WOMAN BALBINA A. YOUNG, Chairwoman

**Transmits the Following with

As Amended:**

An Ordinance Establishing authorization for the City of Providence through its Department of Planning and Development to submit the Community Development Block Grant Application, As Amended.

COUNCILMAN APONTE Moves to Amend item number six, seconded by COUNCILMAN BUTLER.

COUNCILMAN APONTE Moves to amend page one Approved Multi Year, the Salvation Army, the original budget passed by the committee, the amount passed was \$80,000.00, the Salvation Army's needs were \$30,000.00 to re-pay a loan so that reduced the amount in the Approved Multi Year by \$50,000.00 and the adjustment has been made. The Neighborhood Investment Strategy, the formula has also changed, it totals out at \$833,750.00, Addendum A shows all the amendments that have been made there.

COUNCILMAN APONTE Moves to Amend Brassil Park Improvements to be changed to "Fox Point Neighborhood Investment Strategy", also amend

Woonasquatucket Neighborhood Investment Strategy to be changed to "Wanskuck Neighborhood Investment Strategy", seconded by COUNCILMAN BUTLER.

COUNCILMAN APONTE Moves to Amend page number three Rehabilitation & Preservation additional funds were made available for the Cathedral of Life bringing the amount up to \$40,000.00, the amount that was passed in the budget was shy about \$8,750.00, those were recouped and put into that final number of \$6,407,247.00, also an additional \$74,000.00 for a Federal Program that were claimed in the Home Program of \$74,271.00 which is by formula in the Home Program bringing the amount up to \$2,750,458.00, seconded by COUNCILMAN BUTLER.
