AN ORDINANCE IN AMENDMENT OF CHAPTER 21 OF THE CODE ORDINANCES OF THE CITY OF PROVIDENCE ENTITLED "REVENUE AND FINANCE", AS AMENDED.

Approved June 18, 1984

Be it ordained by the City of Providence:

SECTION I. Chapter 21 of the Code of Ordinances of the City of Providence entitled "Revenue and Finance" is hereby amended by adding thereto the following:

"Section 21-28(A). Qualifications of parties doing business with the City of Providence.

(a) In awarding bids for purchase of materials or services by the City of Providence, the Board of Contract and Supply and the Purchasing Department of the City of Providence shall take into consideration, among other factors, the background and reputation for honesty and integrity of the parties who have bid on the particular materials or services. In order to assist the Board of Contract and Supply and other departments of the City of Providence in considering the foregoing, the Mayor, the Finance Director of the City of Providence or the Chairperson of the Finance Committee of the City Council of the City of Providence may request the Chief of the Providence Police Department to conduct a background check on any party bidding or submitting bids for sale of services or materials to the City of Providence and/or any owner, officer or director of any such party. Upon receipt of any such request, the Chief of Police shall conduct such an investigation including, without limitation, to determine whether any such bidding party or any officer, director or owner thereof has been convicted of any criminal offense and shall report his findings to the party requesting such information and to the Board of Contract and Supply.

(b) The results of any such investigations shall be public records of the City of Providence."

SECTION II. This Ordinance shall take effect upon its passage.

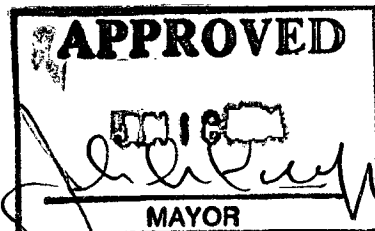
