ORDINANCE SECOND READING

The following Ordinance was in City Council June 3, 1999, Read and Passed the First Time and is returned for Passage the Second Time:

An Ordinance relating to Article IV Chapter 17, Section 17-189(5) of the Code of Ordinances.

Be it ordained by the City of Providence:

Section 1. Notwithstanding the language of Section 17-189(5) of the Code of Ordinances which provides that "[t]he application to

accomplish such [accidental disability] retirement must be filed within eighteen (18) months of the date of the accident," the Retirement Board of the City of Providence, upon the request of the Commissioner of Public Safety, may consider and act upon the accidental disability retirement applications of Police Officer Michael LaMarra, Police Officer Brian

Quirk, Firefighter Robert Tavarozzi and Firefighter Roger Farmer, even though more than eighteen (18) months have passed since the date of the accident which is the averred proximate cause of each of the above-named applicants for a disability retirement allowance.

Section 2. Said applications shall be subject to and considered in accordance with all applicable ordinances, regulations, standards and practices relating to accidental disability retirement applications.

Section 3. This Ordinance shall take effect upon its passage.

Transmits the following with recommendation the same be Approved, as Amended:

Resolution Requesting the City Council to enact legislation that would require safe storage of all firearms and hold adults liable if children gain access to unsecured weapons that are kept in homes for self protection and are stored loaded.

Whereas, Americans own about 200 million firearms, roughly one-third of which are handguns; and

Whereas, Approximately half of United States households report owning one or more guns and many of them are kept in homes for self-protection and are stored while loaded; and

Whereas, Accidental injury and death among children who find loaded weapons have raised a call for preventative measures; and

Whereas, A 1991 General Accounting Office (GAO) Study reported firearms to be the fourth leading cause of accidental death among children between the ages of five and fourteen years of age; and

Whereas, A representative from the American Academy of Pediatrics called firearms death "among the most preventable of all childhood fatalities"; and

Whereas, Most states hold adults financially liable when his/her children gain access to his/her firearm and most states also offer gun safety education and require firearms to have built-in safety features,

Now, therefore, be it Resolved, That the City Council urges the enactment of statewide legislation that would require safe storage of all firearms and that would hold parents liable should his/her child(ren) gain access to loaded, unsecured weapons that are kept in his/her home(s).

PERSONAL EXPRESSION

COUNCILMAN CLARKIN requests the privilege of the floor to speak on a point of personal expression and states:

"As the Good Reverend had just said when he was up here, I wasn't going to speak on this while he was here, but seeing that he left, Violence. Violence isn't always bad. There was a gentleman 81 years of age. This was his third time that he was assaulted. We just saw him on TV. One time he was hit with a two by four. He was in his house the other day, minding his business and some 31 year old man broke in. Luckily for this gentlemen, because he might not be here, he happened to have a shotgun. The gentlemen that broke in went out through a window fairly fast after he got hit in the chest with a shotgun blast. So sometimes having a gun isn't the worst thing in the world. This 81 year old guy . . . I happened to pass him as I left the house tonight. I give him a lot of credit. He said I may be old, but I still have my wits about me and I can pull the trigger.

COUNCILWOMAN DiRUZZO requests the privilege of the floor to speak on a point of personal expression and states:

"I don't have a happy story to relate. On Saturday night, at Grappa, a very dear friend of our family was killed. An innocent person was killed because two young men decided that they didn't like the fact that they were told by someone who was sitting on a boat that was docked at the marina, that you don't urinate in

the river in front of people. Unfortunately, this young man who was 37 years old, Mark Pierce, was a Master Electrician and a very dear friend of my son Billy, who had spent the evening at a family gathering in Matunuk and was called by his friend who had his boat docked at the Mooring, Alan Lachapelle, who owns the boat, to spend the evening on the boat. As a matter of fact, my son was invited to spend the night on the boat as well, but he had to do an interview with some sports legends in New York, so he missed that. Apparently some words were exchanged amongst these two people who were apprehended, 19 and 21 years old, who took it upon themselves because they were told they don't do these things in Providence, decided and made the threat that they were coming back. The police were called twice, and did not appear, and as a result, these two young men went back there and Mark Pierce happened to be coming out of the boat and he was killed with a 22. He never had a chance to live. It is a very sad thing to watch his parents and his family tolerate the grief and the pain that was caused by a very callous act of violence. So we have some good stories to tell, and we have some sad stories to tell. What do you do when things like that happen. A lot of things are happening, because 15 minutes after that another shooting occurred in the Charles Street area. We have to do something about the violence that is coming to our city. This person didn't live in Providence, but he came to Providence to relax and enjoy himself, and he will never be here again. We have to do something about the violence here."

Whereas, The City Council finds that the Fox Point Neighborhood and especially the area of Gano Street which extends from Interstate Highway I-195 to its intersection with Pitman Street is congested with a high volume of traffic, and

Whereas, The City Council finds that the high volume of traffic along Gano Street poses a serious threat to public safety in that both pedestrians and the motoring public may become victims of serious bodily injury, and

Whereas, The City Council finds that the existing zoning and development provisions may be inadequate and/or inappropriate to provide for the safety of pedestrians and the motoring public along Gano Street, and

Whereas, The City Council finds that in an effort to address the effects which current zoning and development provisions along Gano Street may have on the safety of pedestrians and motorists, it has enlisted the Fox Point Citizens Association to develop and propose a plan to address the zoning, development and traffic issues in the Gano Street area, and

Now, therefore, be it Resolved that, The City Council declares a moratorium on the issuance of building permits for new construction, and demolition permits by the Director of the Department of Inspections and Standards, and a moratorium on the granting of relief from the provisions of the Zoning Ordinance by the Zoning Board of Review, for a period of six months commencing on the passage of this resolution for the area along both sides of Gano

Street one-lot deep from Interstate I-195 to Pitman Street.

Be it further Resolved that, This moratorium shall not preclude the Director of Inspections and Standards from issuing permits for renovations of existing structures in accordance with the Zoning Ordinance and Building Code.
