Dear Nick:

It has recently come to our attention that the city has a demolition lien of \$2,400 against our property at 37 Congress Avenue, where we broke ground July 5th for the construction of two \$50,000 town house condominiums.

In clearing the lot, we discovered extensive evidence of an illegal razing of the previous building on the site.

Because of the dumping of the remnants of the former building in the ground, NHS is being forced to spend an extra \$3,000 to clear the area for a foundation.

Therefore, we respectfully request the following:

1. The City Council is to relieve NHS of the demolition lien,
2. The City which ordered and supervised the demolition, is to seek and refund from the original contractor the extra cost to NHS that exceeds the amount of the lien.

Until we can clear up the lien, it will be difficult for NHS to complete the project and to obtain full project financing.
