




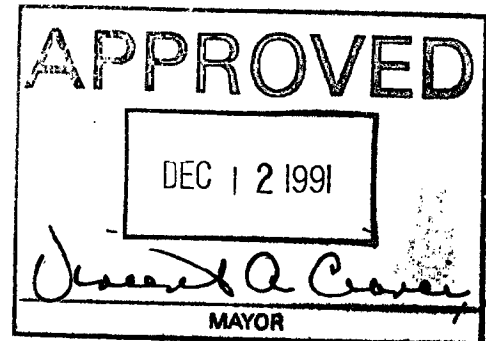

DISPOSITION: Accompanying are Resolutions requesting abatements for the following:

Resolution Authorizing the City Collector to cause taxes to be abated for that building located along One Olneyville Square in the total amount of Nine Thousand, Five Hundred Seventeen Dollars, Eighty-Six Cents (\$9,517.86) for the years 1988 and 1989 as requested by the Providence Public Library.
