The purchase price of said land shall be \$95,000, and any expenditure therein shall be charged to Erco Real Estate Purchase 3-15-00. Said land shall subsequently be conveyed by the City of Providence to the Providence Redevelopment Agency as a non-cash grant-in-aid and for the purpose of expediting the redevelopment of the West River Area.


