Subject: Referral No. 1257 - ZONING CHANGE ON WESTMINSTER STREET

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, March 27, 1962.

This referral is a request for a study, report and recommendation concerning changing of Lots 204, 205 and 518 of Assessor's Plat 35 from an R-4 Residential Zone to a C-4 Heavy Commercial Zone located on Westminster Street. The area contains 19,201 square feet of land.

It was determined on an inspection and photographic survey that the property in question contained three, three-story frame residences with off-street parking.

Although the area directly across Westminster Street is zoned C-4 the rest of the area surrounding the property in question is zoned R-4 residential and is made up primarily of well kept two- and three-family homes. It is felt that the establishment of the requested C-4 Zone would not only downgrade the surrounding residences but also would serve as an invitation to other undesirable uses.

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, February 27, 1962.

This referral is a request for a change in zoning from a C-1 Zone to an M-1 Zone of Lots 361 and 479 on Assessor's Plat 76 located at 155, 157, 159 and 161 Admiral Street.

It was determined on an inspection and photographic survey that the site in question was a vacant lot with the surrounding area predominantly residential.

Reference is made to Referral No. 929 dated May 15, 1956, from the Zoning Board of Review, at which time the petitioner requested permission to erect a one-story masonry building 20' x 40' on Lots 361 and 479 to be used as a pick-up station for a cleaning establishment. It was recommended by the City Plan Commission that the petition be denied because it would establish a nonconforming commercial use in a residential zone. The petition was granted although the building was not constructed. Reference is also made to Referral No. 1157, from the Committee on Ordinances, dated July 12, 1960 at which time the petitioner requested a change of Lots 361 and 479 from an R-3 to a C-1 Zone. The Commission recommended that the petition be denied because of the adverse effects of spot zoning. The petition was approved.

The present referral, if approved, would introduce an M-1 spot zoning situation which would be highly undesirable and detrimental to the surrounding R-3 Zone.





It is our request that if the committee on zoning feels that it is not advisable to approve this petition at this time then a less restrictive zone change be considered and approved such as either a c-2, c-3 or c-4 zone classification.

If we cannot obtain approval to an M-1 zone change then we have no further use for this property. We can, however, make this land available to another concern forced to relocate and wants to remain in this area, but needs a less restrictive zone.

It must be remembered that the land in question was never developed and no building ever existed upon it since the beginning of time. This land serves no useful purposes as it remains, and is an eyesore to the community. Only through this change can the highest and best use of this property be utilized.

It is requested, that immediate action be taken on our petition. We must relocate and vacate our existing premises by June 30, 1962.





Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, December 12, 1961.

This referral is a request for a study, report and recommendation concerning the proposed change of zoning from an R-4 Zone to a C-2 Zone of Lot 88 on Assessor's Plat 23. The area in question contains 4,750 square feet of land.


On an inspection and photographic survey it was determined that the property in question contained a 3-story mixed occupancy frame structure and a 3-stall masonry garage.

The granting of this petition would establish a case of spot zoning. This would create an objectionable situation to residents in the immediate vicinity resulting in the devaluation of their properties. Moreover, the traffic at the intersection on which the property is located is heavy and any further commercial activity would increase traffic congestion in the immediate vicinity. Furthermore, there is ample commercial zoning on nearby Broad Street. Therefore,
