COUNCILMAN IGLIOZZI requests the privilege of the floor to speak on a point of personal expression and states:

"I would like to acknowledge a very special event that is going to happen at 9:26 tonight that Mayor "Buddy" Vincent Cianci, Jr., will

be serving as the longest Mayor of the City of Providence. Since we are having this special Council meeting, I think it is only appropriate that we talk about a very special Mayor. I am very excited about that. I am excited that he is the longest serving Mayor. I am excited about the fact about everything that he has been doing. I am excited about everything that is going on in Providence and I really feel that we are at a very special time in the City of Providence coming upon the Millennium that we have someone who is so dedicated and so committed to the City of Providence and its neighborhoods, and who is willing to extend, work with and be a friend . . . at least I know the people in my neighborhood, and I know people in some of my colleagues neighborhoods, and a guy is simply not just a Mayor, but he is basically the people's Mayor. I think it is a great thing. Last night we had an event. This morning we had an event, and high marks to the presentations to the people that were there and I think we should all take a moment to reflect on that we are actually witnessing history, and we should all be proud of that fact. The people who have been involved in city politics for many years, and people who have been involved in city politics for just a few years were working with someone who is making history and who has made history and who will make history. I am proud that he is the Mayor of Providence, and I am proud that I support him, and I am glad that he is going to be Mayor into the next Millennium, and I am proud that he has already stated that he is going to run for reelection, and I give him my thumbs up, and my vote of approval because I think it is a great thing for all of us, a great thing for Providence and a great thing for our neighborhood.
