CHAPTER 1977-20

No. 341 **AN ORDINANCE** REQUIRING OPERATORS OF SELF-SERVICE
MULTI-DECKED PARKING GARAGES TO PROVIDE ROVING SECURITY
GUARDS DURING PERIODS WHEN THE SAME ARE OPERATIONAL.

Approved May 22, 1977

Be it ordained by the City of Providence:

SECTION 1. All operators of self-service multi-decked parking garages in the City of Providence shall provide roving security guards during such periods when the said garages are operational.

SEC. 2. Violation of this ordinance will cause immediate suspension of license by the license board until a hearing can be given by same and a ruling be handed down.

SEC. 3. This Ordinance shall take effect upon its passage by the City Council and approved by the Mayor.

Dear Mr. Vespia:

I write in reference to the request of Councilman Vincent J. Cirelli, via your office, for crime statistics, specifically of vandalism, occurring within four specified parking garages in the downtown area.

The information system that this department is currently funded to operate is based upon, essentially the reporting of Part I Offenses (as outlined in attachment) based upon their occurrence within Car Posts, which constitute large geographic areas.

We do not, therefore, have the capability to respond to a request that directs itself to a specific location(s) within a car post, or to a crime other than one classified as a Part I Offense. Vandalism or Malicious Mischief is not included within this category.

Barring the use of electronic data processing equipment, and the system currently in use, this information could be culled from the reports on file within our Bureau of Records. This office handles approximately 70,000 reports on a yearly basis.

In order to come up with a valid sample, I would have to assign a man to go back, and manually tabulate, about six months reports, or approximately 35,000 reports. The time necessary to compute this data would not be measured in days, but in weeks.


I have authorized a study of the investigative assignments for Part I Offenses occurring within these locations, and those figures are contained in the attachment.

It would appear from the figures cited that there is a crime problem in these locations, and one that I have dealt with on a regular basis.

In order that this department might more fully, in the future, respond to such inquiries, and be able to respond tactically to such crime patterns, my staff is currently studying the application of better data processing systems than those currently being utilized.

However, due to funding and programming limitations, I am unable to respond directly to the request, at least as of this time, beyond that which is contained in the attachment.

I write in regard to the your inquiry of the 2nd, regarding the enforcement of Ordinance # 341, relating to security in multi-level garages, which I partially responded to in my interim communication of the 6th.

Sergeant Walter J. Campbell, of the License Investigation Unit of the Providence Police Department conducted an investigation on December 6, regarding these garages with the following results:

Mr. Alfred Parrillo, manager of the Majestic Garage stated that he has men who work day and night as a roving patrol. Mr. Parrillo further stated that it was his understanding at the council hearings that he could use his hired personnel as security and not be required to employ people from Pinkerton or the like.

Mr. William Tanaglia of the Outlet Company stated that he has hired personnel who make the rounds as a roving patrol.

Mr. Allan Lettieri who was tending the register at the APCOA Garage at 29 Eddy Street stated that he did not work alone, that there were at least two men during the day who would alternate their duties. In the latter part of the evening, there is no need to tend the register, and this individual acts as the roving patrol.

Additionally, Sergeant Campbell determined that the two story garage on Weybosset at Richmond is owned by the Meyers Brothers, and that they have two men on duty, and utilize a regular roving patrol.

It would appear, therefore, that compliance is being made by these garages by the use of their own employees for patrolling, rather than outside "security guards".

As there is at least a question as to whether this is full compliance with the intent of the ordinance, I have requested a full opinion from Acting City Solicitor Ronald H. Glantz as to his legal opinion of what is required from the garages for compliance.

In the interim, the increased security force currently detailed to the downtown area, and specifically the garages, should deter any problem from developing.

At such time as I have had a report from Mr. Glantz, I will render a further report to the City Council, through your office.
