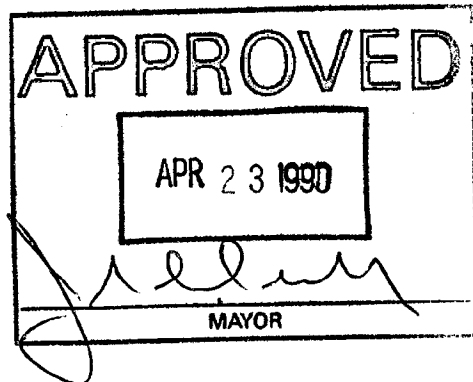

Pursuant to yours and Councilman Lombardi's request I am forwarding the following information so that the taxes for the above captioned lots can be abated.

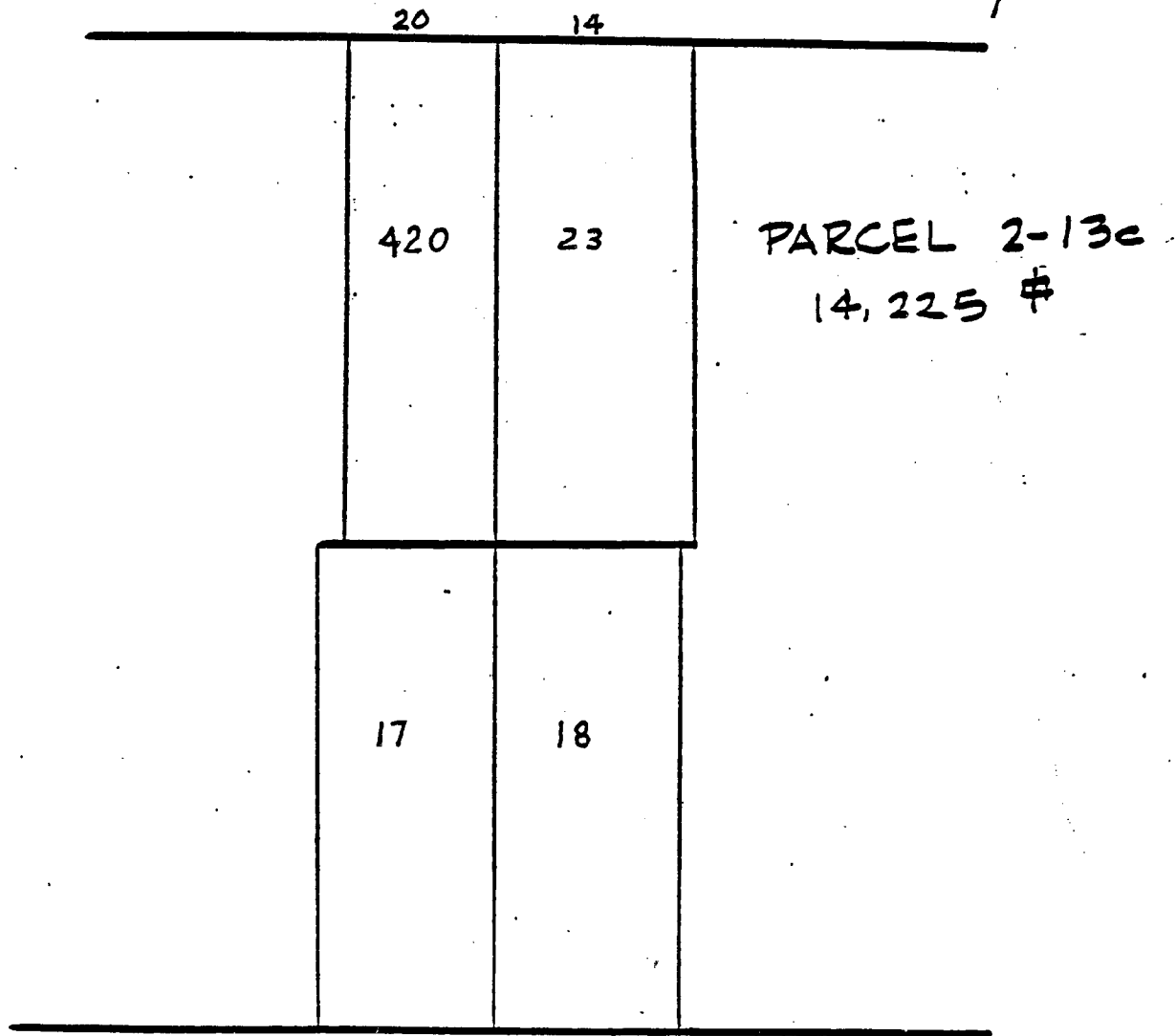
