## CHAPTER 1974-1

No. 1 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1973-28 APPROVED JUNE 25, 1973 BY APPROPRIATING THE SUM OF TWO HUNDRED TWENTY FIVE THOUSAND (\$225,000.00) DOLLARS TO VARIOUS ITEMS IN VARIOUS WATER DEPARTMENTS.

Approved January 9, 1974

*Be it ordained by the City of Providence:*

SECTION 1. Chapter 1973-28 of the Ordinances of the City of Providence, as approved June 25, 1973, entitled: "An Ordinance Making Appropriation of \$80,014,799.31 for the Support of the City Government for the Fiscal Period Beginning July 1, 1973 and ending June 30, 1974", as amended, is hereby further amended by appropriating the sum of Two Hundred Twenty Five Thousand (\$225,000.00) Dollars as follows:

SECTION 2. The said sum of Two Hundred Twenty Five Thousand (\$225,000.00) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer Two Hundred Twenty Five Thousand (\$225,000.00) Dollars from Water-Transmission and Distribution - Water Depreciation and Extension Fund to the Receipt Account.

SECTION 3. This Ordinance shall take effect upon its passage.
