of Employees in Certain Classes in the Providence Water Supply Board in
Repealing Ordinance Chapter 1996-44, Approved November 15, 1996.

Be it ordained by the City of Providence:

1 Senior Technician

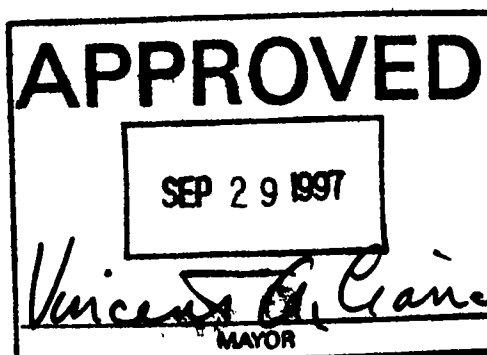
Section 4. This Ordinance Amendment shall take effect upon passage.


