That the portion of Moore Street from Elmwood Avenue to its westerly termination, shown as shaded area and designated by the letters A-B-C-D on the accompanying plan entitled, "Providence, R. I., P.W. Dept.--Engineering Office, City Property Section, Plan No. 062683, Date September 9, 1964", has ceased to be useful to the public and the same is abandoned as a public highway and the damage to the abutters is appraised at nothing and so awarded and it is further

ORDERED, That the Superintendent of Street Signs and Numbers be and he is hereby directed to cause a sign to be placed on the portion of Moore Street from Elmwood Avenue to its westerly termination, abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper published in the County of Providence, at least once each week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting on the portion of Moore Street from Elmwood Avenue to its westerly termination which has been abandoned, who is known to reside within this State.

Dear Councilman Matera:

Under date of September 4, 1964, we received an official memorandum from the Office of the City Clerk in which they enclosed a petition to the City Council requesting the abandonment as a public highway Moore Street from Elmwood Avenue to its westerly termination. We have checked our facilities in that portion of Moore Street being considered for abandonment and the following is the depreciated value of our facilities in this highway:

222.37 ft. of 6" C.I. Main installed in 1873	\$393.15
6" Gate Valve #R40.14 installed in 1889	Nil
Post Hydrant #P-564 installed in 1954	504.17
2" C.I. Service #29675A installed in 1949	102.97
6" C.I. Fire Service #71123 installed in 1964	<u>310.86</u>
Total depreciated value	\$1,311.15

The 2" service #29675A as well as the 6" cast iron fire service #71123 are in use at the present time and furnish a general supply as well as a fire supply to the Koda Realty Corp. (United Camera, Inc.) at 297 Elmwood Avenue. In the event that this portion of Moore Street is abandoned, it will be necessary for the Koda Realty Corp. to relocate these services so that they will enter the property from Elmwood Avenue. They will also have to relocate the meters on both the general as well as the fire supply. In acting on this matter, we would like to suggest that the Committee inform the Koda Realty Corp. that both services as well as the meters will have to be relocated and will have to be supplied from the Elmwood Avenue main requiring piping changes within the building.

We are forwarding a bill to the City Collector's Office in the amount of \$1,311.15 and request the Committee's consideration in withholding final action on this matter until a check is deposited with the City Collector covering the above amount.



The subject referral received consideration by the City Plan Commission at a meeting held on Thursday, October 1, 1964.


This referral is a request to abandon as a public highway a portion of Moore Street from Elmwood Avenue to its westerly termination.




