WHEREAS, the administration of the City of Providence, in accepting that decision, is preparing to pursue the necessary remedy as accorded by said Court.

NOW THEREFORE BE IT RESOLVED, That the City Council is hereby authorized to create a Special Committee, to consist of five of its Members, who shall be appointed by the President of the City Council, for the purpose of studying and reporting back to said Council, the reapportionment and the redistricting of all the Wards in the City of Providence.
