1. Made enormous progress toward the completion of Mayor Cianci's master plan for the complete restoration of Roger Williams Park.

2. Rebuilt neighborhood parks such as Washington Square, Columbus Square, Hopkins Square, Lippitt Park, Market Square and are beginning more such improvements this year,

3. Greatly encouraged and promoted the use of City parks with a professionally managed year series of free cultural events entertaining 85,000 citizens last year,

4. Placed the Forestry Division on a sound professional basis, planting thousands of new trees and providing preventive surgery for older trees,

Diamond has implemented a department wide professional policy including the use of blue ribbon committees of private citizens to ensure the appointment of executive staff solely on the basis of merit; the enforcement of Section 4.29 of the City Charter and of the City's residency requirements for all executives and has substantially achieved the 15% goals of the City's affirmative action plan for Blacks and Women two years ahead of schedule, and

Whereas, Superintendent of Parks James W. Diamond and his staff have been repeatedly and continuously supported and commended for these endeavors by numerous civic organizations including the Friends of Roger Williams Park, the Rhode Island Federation of Garden Clubs, the Rhode Island Horticultural Society, the Rhode Island Zoological Society, the Zoo Decent Council, the Providence Street Tree Committee and many others as well as the Board of Park Commissioners and have exhibited exceptional professionalism and dedication in the execution of their duties,

Whereas, Although the Administration Bill to re-authorize General Revenue Sharing will not be submitted to Congress until early fall, there is discussion in Congress of reducing General Revenue Sharing in fiscal year 1980, as a budget cutting measure, and

Whereas, The General Revenue Sharing allotment for the City of Providence is vitally important to balancing the City Budget, and

COUNCILMAN JOHNSON:

Whereas, Among the consequences for the City of Providence if General Revenue Sharing is not Re-Enacted, there will necessarily be an increase in the property tax and a reduction in spending for required City Services,

Now, Therefore, be it Resolved, That the City of Providence urges the Members of the Rhode Island Congressional Delegation to support Re-Enactment of General Revenue Sharing, and

Be it further Resolved, That the City of Providence urges the Members of the Rhode Island Congressional Delegation to Act upon General Revenue Sharing Re-Enactment in time for the City of Providence to plan their fiscal year, 1981 Budget.

Resolution Urging the Rhode Island Congressional Delegation to Support the Enactment of Countercyclical Fiscal Assistance.

Whereas, Last session, Congress failed to re-enact Countercyclical Fiscal Assistance for fiscal year, 1979, and

Whereas, The City of Providence will be forced to reduce services to be financed with those Countercyclical Fiscal Assistance Funds and may ultimately eliminate services which were previously financed with those funds, and

Whereas, Last session's Senate-passed bill to renew Countercyclical Fiscal Assistance is pending in the House (H.R. 1246) and the Senate (S. 200), and

Whereas, The Senate-passed bill generally provides aid to all local governments with at least Six Percent (6%) unemployment, and

Whereas, The unemployment rate in the City of Providence has been consistently above Six Percent (6%), and

Whereas, Countercyclical Fiscal Assistance is urgently needed in cities with high unemployment and will be needed in many more cities if an economic downturn occurs later this year or in 1980,

Now, Therefore, be it Resolved, That the City of Providence urges the Members of the Rhode Island Congressional Delegation to support enactment of Countercyclical Fiscal Assistance Legislation, in time for the City of Providence to plan their fiscal year, 1980.

COUNCILMAN MOISE, COUNCILMAN O'CONNOR and COUNCILMAN EASTON:
