Resolution of the City Council Approving the Providence Housing Authority's Replacement Housing Plan and Application for the Demolition of 32 Units of Public Housing contained within Four Buildings on Barry Road, Providence, Rhode Island.

Whereas, It is not feasible for the Providence Housing Authority to include 32 dwelling units within four buildings on Barry Road in its proposed program of comprehensive modernization at the Hartford Park Public Housing Project because of applicable development limits, as determined by the U.S. Department of Housing and Urban Development, will be exceeded, and

Whereas, The physical condition of the Barry Road area is overcrowded and adverse to the health, safety and welfare of Project residents, and

Whereas, It is the intention of the Housing Authority to provide safe, decent and sanitary housing and to comply with all applicable federal, state and local laws, regulations and requirements, and

Whereas, The Code of Federal Regulations (24 CFR 970.8) requires a statement from the unit of general local government in which the project is located, indicating approval of the Authority's

replacement plan for units proposed for demolition, and

Whereas, The Housing Authority's replacement plan calls for the construction of thirty two new public housing units within the Hartford Park Development on land currently occupied by three high-rise buildings previously approved for demolition, and

Whereas, The Housing Authority has certified that: (1) the relocation resources for displaced families shall be decent, safe, sanitary and affordable, (2) no demolition shall take place until all displaced tenants have been successfully relocated, unless there is to be staged relocation and staged demolition, and (3) the Authority's action is in compliance with applicable civil rights laws and compliance agreements,

Now, therefore, be it Resolved, That the City Council of the City of Providence hereby approves the Providence Housing Authority's replacement housing plan and application for the demolition of 32 units of public housing contained within four buildings on Barry Road, Providence, Rhode Island.

COUNCIL PRESIDENT PRO TEMPORE STRAVATO IN THE CHAIR

COUNCILMAN GLAVIN: As we know, tonight is our esteemed colleague, Thomas F. O'Connor, Jr.'s last official Meeting as a member of the Providence City Council and it would be remiss on my part if I did not say a few words. Very briefly, it has been a pleasure to serve ten years with Tom O'Connor and over that time since we began our tenure there has been respect among our colleagues. At that time, it was not the most peaceful time on this body. It was a different administration and different personalities and the City was faced with many problems. We had far to go to understand many of those problems we first addressed ten years ago. Many have been addressed or alleviated and in some way, Tom O'Connor had a hand in addressing those issues.

On a personal note, I had the pleasure of attending a conference with Tom O'Connor and we roomed together for five or six days in San Antonio, Texas. We got to know each other better than we did before. We learned many things and brought them back to the City of Providence and learned some things about each other. Tom is one of the more dynamic people on the council and I mean that in every sense of the word, he has been a leader in many ways. He was Chairman of the Committee on Urban Redevelopment, Renewal and Planning for many years and did an outstanding job in that capacity. I will miss Tom on the City Council and hope that he will stay in City Government, he has a lot to contribute. His dedication is his single most important quality.

All of us will miss him but do welcome his replacement, who will have the same enthusiasm as Tom O'Connor.

On behalf of myself and my colleagues, I wish Tom and his wife Donna and family, health and happiness and good things in the future.

COUNCILWOMAN DIRUZZO: I would be remiss if I did not say a few words. I met Tom sixteen years ago when I was appointed to the Providence School Committee. I missed him on the School Committee when he left and I will miss him on the council. He has served the City well in all his years on the Council and on the School Committee for the Betterment of the community and the people. He has served as an exemplar for his community and I know he will continue his diligence for as long as he lives in the City of Providence.

We will all miss his presence on the City Council.

COUNCIL PRESIDENT EASTON: I don't think anyone will be surprised when I tell you this is the most difficult evening on my job. I don't think anyone has had a closer relationship or benefitted more than my association with Tom O'Connor.

I have spent some time over the recent weeks to thank Tom for what he has done for the City, but it is not possible.

We are all familiar with Tom's qualities and what he brings to the services of the City of Providence. He has proven himself as a person of tremendous political skill.

He has been the ultimate gentleman on this body as well as being intelligent and honest. His sincerity and devotion to his community and family has been exemplary. (He refers to a library in Councilman O'Connor's home).

I got the closest when we went through the tax crisis. We all (names Finance Committee members at that time) realized the enormity of the issues we were dealing with and that we had to come

to a conclusion. (He refers to former Mayor Cianci and the City Council).

Tom O'Connor always knew what to do every day when we went through that crises. He said we made a decision, we knew what we had to do and we will do it.

Of the things he is most proud, they are his family, community, his nationality and his service as a Marine.

COUNCIL PRESIDENT PRO TEMPORE STRAVATO: It has been a pleasure serving with him and I wish him and his family the best in the years to come and with the new year.

COUNCILMAN ROLLINS: It has been a pleasure serving with Councilman O'Connor for the past two years.
