CHAPTER 1021

No. 212 AN ORDINANCE

AMENDING CHAPTER 987 BY ADDING THE SUM OF
TEN THOUSAND FIVE HUNDRED (\$10,500) DOLLARS TO THE APPROPRIATION
CONTAINED THEREIN FOR RECORDER OF DEEDS, ITEMS 1 and 5.

Approved March 16, 1956

Be it ordained by the City of Providence:

SECTION 1: Chapter 987 of the Ordinances of the City of Providence as approved September 16, 1955, entitled: "An Ordinance Making Appropriation of \$31,832,600.04 for the Support of the City Government for the Fiscal Year Ending September 30, 1956", as amended, is hereby further amended by adding the sum of Ten Thousand Five Hundred (\$10,500) Dollars to the appropriation contained therein for RECORDER OF DEEDS, ITEMS 1 and 5. Said sum of Ten Thousand Five Hundred (\$10,500) Dollars shall be apportioned as follows: ITEM 1 - \$2,000; ITEM 5 - \$8,500.

SECTION 2: The said sum of Ten Thousand Five Hundred (\$10,500) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3: The Estimated Receipts from Reserve for Extraordinary Expenditures are hereby increased by Ten Thousand Five Hundred (\$10,500) Dollars.

SECTION 4: This Ordinance shall take effect upon its passage.
