Ordered, That the Mayor is hereby authorized and directed for and on behalf of the City, to execute and deliver an agreement among the parties as set forth above, which said agreement shall be in such form, with such changes therein as may be approved by the Mayor so executing the same and such approval to be conclusively evidenced by his execution and delivery thereof, and by which the City agrees to be bound.

Read and Passed, on motion of COUNCILMAN FLYNN, seconded by COUNCILMAN ALMAGNO.

The motion for Passage is Sustained.

ADJOURNMENT
