Cheryl M Fisher – Allen

Cheryl M Fisher –Allen was born in Providence on August 8, 1950. She was a graduate of Gilbert Stuart School, Central High School and Rhode Island College where she earned a bachelor of science in education. She taught in several Providence Schools, including E.W. Flynn Elementary, Dr. Martin Luther King Elementary, Nathaniel Greene Middle School, Gilbert Stuart School and Alfred E. Lima Elementary School. In 1991 she earned the Milken Family Foundation's National Educator Award. The Milken Award cited her innovative curriculum on conflict resolution and her involvement of the community in a celebrity reader program. With the \$25,000 grant that came with the Milken award she established the Charles J Fisher Jr. overall improvement award named for her father gave it out annually to a graduating elementary school student. The Milken Award was one of many accolades Cheryl Fisher –Allen received during her career. In 1985, she was cited by the Speaker of The House of Representatives for coordinating the program called "Children helping Children" a citywide fundraising campaign for victims of famine in Ethiopia. In 1988 she was proclaimed Teacher of the Year and was honored with a resolution from the City Council. Cheryl was part of the "Teaching Matters" roundtable, a year long project started in 1997 by the Providence Journal and Channel 10 to examine public education in Rhode Island. Her greatest pride was a play about the civil rights movement that her students produced in 1984, which was attended by Rosa Parks. Cheryl Fisher Allen was also a recipient of the John Hope Settlement House Paris Vaughn Sterret Award for outstanding leadership and service, the Central High School 1991 Alumnus of the Year Award and the 1995 PROBE Excellence and Education Award. She was a member of the Rhode Island State Ethics Commission, the Providence Teachers Union, the West End Community Center, and the Alfred Lima School Design Team for two way bilingual education. She leaves a daughter Che'La and her niece April Dennis and her two nephews Jason and Kori Dennis! Her husband Leonard Allen and her Sister Deborah Dennis have since passes away! She passed away on September 9, 1999.

Chairwoman McConnell requested to move agenda items out of order beginning with agenda item number VI.

AUTHORIZATION TO DEVELOP ROGER WILLIAMS PARK BROAD STREET GATEWAY AT 1197-1207 BROAD STREET, PLAT-53, LOTS 511, 515, 525. Bonnie Nickerson, Director of Planning/Executive Director of Providence Redevelopment & Wendy Nilsson, Superintendent. Discussion and vote.

Director Nickerson was unable to attend. Superintendent Nilsson addressed the board to discuss the plans to develop the RWP Broad Street Gateway. She explained that The Roger Williams

Park Broad Street Gateway project is being led by the Providence Redevelopment Agency (PRA) in close partnership with the Department of Parks, and has the enthusiastic support of numerous community partners and neighborhood organizations. The proposed project will promote the ongoing redevelopment of Broad street by transforming three prominent blighted Broad Street lots adjacent to Roger Williams Park in Providence's Washington Park neighborhood into a modern, green and energy efficient, multi-purpose center to welcome visitors to both the Park and the Washington Park neighborhood/Broad Street Corridor. The Welcome Center will become a gateway from Broad Street to the Park's many recreational opportunities and will greatly improve the lens through which park visitors see the Broad Street Neighborhood, and how neighbors view their connection to the park. The Gateway seeks to improve the livability of the Washington Park neighborhood as it leverages significant public and private investments made by the City of Providence, Rhode Island Housing, the Rhode Island Foundation, and others both along Broad Street and in Roger Williams Park.

The PRA, in partnership with project team, submitted a grant application to the RI Housing Authority in the summer of 2018 to partially fund this project [Exhibit-A]. Other funds have been identified through the PRA. Ultimately, the application was not successful because of the absence of site control. However, since site control has since been established via eminent domain, the application will be re-submitted in February 2019. If the application is approved, the PRA and project team, including Parks, will move forward with Community meetings to better define the concept.

Commissioner Gordon-Martin asked who would staff the center and Superintendent Nilsson commented that staffing will need to be explored, but generally, the project team was thinking about a cohort of trained volunteer docents/interns from local universities like Johnson and Wales and Roger Williams University.

Upon arrival of Chairman Elorza at 9:15 a.m., Commissioner McConnell relinquishes the chair.

With no further questions or comments Chairman Elorza entertains a motion to authorize the development of the Broad Street Gateway. On motion by Commissioner Narducci and seconded by Commissioner Gordon-Martin. Motion passes.

AUTHORIZATION TO MOVE VERRAZANO MONUMENT FROM MEMORIAL SQUARE TO ST. JOHN'S PARK. *Wendy Nilsson, Superintendent and Rick Simone President of EGN Consulting. Discussion and vote.*

Superintendent Nilsson re-introduced this item to the Board and highlighted the key points previously discussed during the November 1st, 2018 Board meeting where authorization to move the Verrazano Monument [Exhibit-B] from Memorial Square to St. John's Park was tabled for 30-days in order for the public to be properly notified during a 30 day period.

Superintendent Nilsson explained that relocating the memorial from Memorial Square to St. John's Park will have the additional benefit of providing more space for visitors to appreciate the individual memorials in the square. Commissioner McConnell and Commissioner Narducci both asked if the public made any negative comments about this request. Superintendent Nilsson added that she has not received any negative or positive feedback as a result of the 30 Day Public Notice posting. Superintendent Nilsson acknowledged Mr. Rick Simone from the Federal Hill Commerce Association. Mr. Simone added that all of the societies with whom he discussed the relocation, were in full support.

Chairman Elorza entertained a motion authorizing the move of the Verrazano monument from Memorial Square to St. John's Park, on motion by Commissioner Narducci, seconded by Commissioner McConnell. Motion is approved.

AUTHORIZATION TO NAME WALDO STREET TOT LOT, THE CHERYL M. FISHER-ALLEN TOT LOT. *Wendy Nilsson, Superintendent. Discussion and vote.*

Superintendent Nilsson addressed the board as she introduced this item on behalf of Councilman Taylor, who was unable to attend the meeting today. She explained that the Waldo Street Tot Lot is a very small tot lot that is outdated and in need of renovations. The Parks Department plans to renovate the park in spring/summer 2019. Councilman Taylor requested that the Waldo Street Tot Lot be renamed the Cheryl Fisher-Allen Tot Lot. Cheryl Fisher-Allen was a community advocate and a dedicated school teacher at Gilbert Stuart. Commissioner Narducci also spoke on behalf of Councilman Taylor as he explained that Councilman Taylor would be very appreciative if this cause is supported by the Commission. He added that former Councilman Jennings was also an advocate of this naming the park after Cheryl Fisher-Allen. [Exhibit-C].

Chairman Elorza asked if there is a policy regarding setting standards for the process of renaming the Parks since there has been an influx of similar requests made to the commission in recent years. Superintendent Nilsson explained that essentially, a person would have to be deceased and would have made major contributions to the community. There is a policy established by the BOPC that details the exact process. She further indicated that letters of support should also be submitted to the commission to show support for the name change from the community. Chairman Elorza asked for a review of the formal process for renaming parks.

With no further questions or comments Chairman Elorza entertains a motion to name Waldo Street Tot Lot, The Cheryl M. Fisher-Allen Tot Lot, on motion by Commissioner Narducci and seconded by Commissioner Gordon-Martin. Motion passes.

AUTHORIZATION TO NAME THE NEW PLAYGROUND AT PRETE-METCALF FIELD, VALENTINO “VAL” INNOCENTE PLAYGROUND. *Wendy Nilsson, Superintendent. Discussion and vote.*

Superintendent Nilsson deferred the discussion to Commissioner Narducci after emphasizing that the naming is for the new playground at Prete-Metcalf, not the park itself. Commissioner Narducci addressed the commission and explained his support for naming the playground after Coach Valentino Innocente. Commissioner Narducci discussed that Coach Valentino [Exhibit-D] was his coach when he was a student at LaSalle High School. He shared his connection to the coach and the coach’s connection to the youth in the community. He further explained that Coach Valentino cared for his parents and his disabled brother, and as such never had a family of his own. Instead, he dedicated his life to mentoring the community youth. He also served on the democratic committee and coached Little Leagues at Prete-Metcalf field as well as Bishop Hendricken High School teams. Later in his career, he became a well-admired coach at Roger Williams University. Coach Valentino also motivated college students to assist with the Little Leagues at the field. Commissioner Narducci added that Coach Valentino was so well revered in the community that the community planted a tree in his memory at Prete-Metcalf field.

Commissioner McConnell asked if any constituents would be offended by this request and Commissioner Narducci said no.

Chairman Elorza entertained a motion to name the new playground at Prete-Metcalf field, Valentino “Val” Innocente Playground, on motion by Commissioner Gordon-Martin and seconded by Commissioner Cepeda-Andujar. Motion passes.
