
Dear Mr. DiMase:

The attached plans submitted for the proposed gasoline station at the northwest corner of Smith and Holden Streets have been reviewed.

In order for the proposed development of the gasoline station at this location to be acceptable to this office, the following revisions will be necessary:

- 1) The maximum curb opening of the three driveways (two on Smith, one on Holden) shall be twenty-five feet.
- 2) The first curb return on Smith Street west of Holden shall be ten feet from the property line of Holden Street, rather than the five feet indicated on the plan submitted (#BOS 2340, dated March 7, 1962).
- 3) There shall be a 6"x6" barrier provided separating the paved lot area from the adjoining sidewalk along the Smith Street frontage in all areas other than those used by a driveway. The opening in this barrier may be thirty-five feet.
