No. 144 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE, CHAPTER 1981-39, EFFECTIVE JULY 20, 1981, RELATIVE TO THE WATER DEPARTMENT.

Approved March 26, 1982

Be it ordained by the City of Providence:

SECTION 1. Section 16 of Chapter 1981-39 of the Ordinances of the City of Providence effective July 20, 1981 and entitled, "An Ordinance Making an Appropriation of One Hundred Forty-Nine Million, Eight Hundred Sixty-Two Thousand, One Hundred Twenty-Two Dollars and Nine Cents (\$149,862,122.09) for the Fiscal Year Ending June 30, 1982," is hereby amended, as follows:
