No. 62 AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1981-39, EFFECTIVE JULY 20, 1981, BY TRANSFERRING THE SUM OF TWELVE THOUSAND DOLLARS (\$12,000) WITHIN THE PUBLIC WORKS WASTE COLLECTION PROCESSING ACCOUNT FROM 1-05-07 ITEM "2" TO 1-05-07 ITEM "189".

Be it ordained by the City of Providence:

SECTION 1. Chapter 1981-39, of the Ordinances of the City of Providence, effective July 20, 1981, entitled: An Ordinance Making an Appropriation of One Hundred Forty-Nine Million, Eight Hundred Sixty-Two Thousand, One Hundred Twenty-Two Dollars and Nine Cents (\$149,862,122.09) as amended, is hereby further amended by transferring the sum of Twelve Thousand Dollars (\$12,000) within the Public Works Waste Collection Processing Account from 1-05-07 Item "2" to 1-05-07 Item "189".

SECTION 2. This Ordinance shall take effect upon its Passage.
